VULNERABLE ADULT STATEMENT

The Archdiocese recognises that there are many people with whom Church personnel have contact who require special care and attention. The Archdiocese values and encourages the participation of vulnerable adults in all parish liturgies and activities that enhance their spiritual, physical, emotional, intellectual and social development. We believe that all Church personnel, including priests, religious, staff and volunteers must carry out their ministry respecting the rights of the individual in line with gospel values and human rights legislation. The Archdiocese recognises and upholds the dignity and rights of vulnerable adults and is committed to safeguarding all our members.

I wa<mark>s ask</mark>ed by my Parish Priest a few years ago to become a Parish Rep.

There are usually two Parish Reps in each parish and maybe more, depending on the size of the Parish.

Training is provided by the Archdiocese for those taking up the role. Support and advice are always available through the Director of Safeguarding.

The role of the Parish Rep is:

- To raise awareness of what Child Safeguarding in the Church is.
- To ensure that the Child Safeguarding Policy Statement is displayed prominently in the Church and other Church places where the public have access.

- To ensure that it contains contact information for safeguarding personnel in the diocese, the Gardaí and TUSLA.
- To ensure that Church activities are provided in a way that protects the safety and wellbeing of children and vulnerable people.
- To meet regularly with the priest to monitor safeguarding practices in the parish and assist the priest in completing the annual audit.

The work of safeguarding children in our Church is everyone's responsibility and I would encourage and urge people in parishes to consider taking up this role, if invited to do so. It is not an onerous task; support and guidance is available and all the procedures are now in place, our role is to monitor and adhere to them."
